NOW, THEREFORE, in consideration of the premises and the sum of 35 in hand faid by the Trustee to the Corporation; the receipt whereof by the Corporation prior to the execution and delivery of this Supplemental Indenture is hereby acknowledged, this Supplemental Indenture witnesseth as follows:

- Supp. Ind.

1. The Corporation has executed and delivered this Supplemental Indenture and has granted, bargained, sold, conveyed, warranted, assigned, transferred, mortgaged, pledged and set over, and by these presents does hereby grant, bargain, sell, convey, warrant, assign, transfer, mortgage, pledge and set over, unto the Trustee and its successor or successors and its or their sanighs, all and eingular the real and personal property of the Corporation falling within the classes of property embraced in the description of the "Trust Estate" set forth in the Indenture, including, without limitation, all and singular the real and personal property of said description heretofore or hereafter acquired by on constructed by or on behalf of the Corporation, and wheresoever situate, both real and personal, tangible and intangible, located or to be located in the Counties of Douglas, Franklin, Hiami and Johnson in the State of Kansas, constructed or to be constructed with the proceeds of the loan made pi summa to a telephone loan contract dated as of December 6, 1951, by and between the Corporation and the Government as the same may be amended from time to time, and also including, without limitation, the following described groperty, to wit:

> All that tradt or percel of land conveyed to the Corporation by Ross Gault and Hazel Gault, his wife, by deed dated Marsh 10, 1952, and recorded in the Office of the Recorder of Deeds, Franklin County, Kansas, in Book of Deeds No. 168, page 395, on April 9, 1957, said lands being more perticularly described was beginning on the East line of Main Street, Wellswille, Kansas, at a point in the center of the North well of the one story brick building now on Lot 2 in Block "C" of Elder's right of way addition to town of Wellswille, Kansas, thence South along the East line of Main Street to a point in the center of the North wall of a one story orick building now on Lot 3 in Block "C" of Elder's right of way addition to Wellswille, Kansas, thence East along a line in the center of said wall and extended beyond skid wall to the alley in said Block "C"; thence Morth along the Mast line of said alley to where it intersects the center line. Extended of the North brick wall now located on Lot 2 of said Block "C" Elder's right of way addition to Wellswille, Kansas, thence West along center line of said North wall extended to said wall, thence continuing West in center of said North wall to be alley in said Block "C", thence Said North wall be the said genter line of said North wall extended to said wall, thence continuing West in center of said North wall

and all plants, works, structures, erections, buildings and improvements now or hereafter located on said tract or parcel of land and all tenements, hereditaments and appurtenances now or hereafter thereauto belonging or appertaining together with all rents, income, revenues, profits and benefits at any time derived, received or had from any and all of the above-described property of the Corporation, TO HAVE AND TO HOLD the same unto the Trustee and its successor or successors and its or their assigns forever, in trust nevertheless, for the uses and purposes, and upon the trusts, terms, provisos and agreements expressed and declared in the Indenture, as shended and supplemented hereby.

2. The Outstanding Notes are hereby confirmed as notes of the Corporation entitled to the security of the Indenture, as amended and supplemented by this Supplemental Indenture, and of the property by the Indenture and this Supplemental Indenture mortgaged and pledged, or intended so to be, equally and ratably with a cother and with other notes of the Corporation when and as executed and the property by the Indenture, as amended and supplemented the y, without preference, priority or distinction of any one of the Cutstanding Notes or such other notes over any ether thereof, and irrespective of the dates of the execution, delivery or maturity thereof, gr of the assignment or negotiation thereof.
