PARTIAL RELEASE OF LIEN OF TRUST INDENTURE
DATED JULY 1, 1939 AND INDENTURES SUPPLEMENTAL THERETO,
OF THE KANSAS POWER AND LIGHT COMPANY.

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, The Kansas Power and Light Company, a corporation organized and existing under and by virtue of the laws of the State of Kansas and having its principal office in the City of Topeka, Kansas (hereinafter called "Company"), on or about July 1, 1939, made, executed, acknowledged and delivered to Harris Trust and Savings Bank, a corporation organized and existing under the laws of the State of Illinois and having its principal office and place of business in the City of Chicago, Illinois, as Trustee, a certain mortgage and deed of trust dated as of July 1, 1939, (hereinafter called "Original Indenture") to secure First Mortgage Bonds of the Company issued and to be issued thereunder, which Original Indenture was filed for record in the Office of the Register of Deeds of Douglas County, Kansas, on November 17, 1949, as a real estate mortgage in Book 97, Page 1, and as a chattel mortgage #4737; as amended and supplemented by a Supplemental Indenture dated April 1, 1949, filed and recorded in the office of said Register of Deeds on November 17, 1949, as a real estate mortgage in Book 97, Page 82, and as a chattel mortgage #4739; as amended and supplemented by a Supplemental Indenture dated October 1, 1949, filed and recorded in the office of said Register of Deeds on November 4, 1949, as a real estate mortgage in Book 96, Page 525, and as a chattel mortgage #4542; as amended and supplemented by a Supplemental Indenture dated December 1, 1949, filed and recorded in the office of said Register of Deeds on January 6, 1950, as a real estate mortgage in Book 97, Page 201, and as a chattel mortgage #55; as amended and supplemented by Supplemental Indenture dated December 1, 1951, filed and recorded in the office of said Register of Deeds on December 14, 1951, as a real estate mortgage in Book 101, Page 195, and as a chattel mortgage #5568; and as amended and supplemented by a Supplemental Indenture dated May 1, 1952, filed and recorded in the office of said Register of Deeds on May 19, 1952, as a real estate mortgage in Book 102, Page 1, and as a chattel mortgage #2212, to which Indentures and the record thereof as aforesaid reference is hereby made; and

WHEREAS, Company proposes to transfer and convey the real estate herein-after described and has complied with the requirements of said Indenture and is entitled to the release of said property from the lien thereof.

NOW, THEREFORE, in consideration of the premises and of the sum of One Dollar (\$1.00) to the undersigned, Harris Trust and Savings Bank, Trustee, paid, receipt whereof is hereby acknowledged, and pursuant to the request of Company, the undersigned, as Trustee as aforesaid, has remised, released, and quitclaimed and does hereby remise, release, and quitclaim unto said The Kansas Power and Light Company and to its successors and assigns, all right, title, interest, claim, and demand which the undersigned, as Trustee as aforesaid, may have acquired under and by virtue of said Indenture, and any indenture supplemental thereto, in and to the said real estate situated in Reserve No. 7 and Reserve No. 6 in the City of Lawrence, Douglas County, Kansas, described as follows, to-wit:

Beginning at a point on the North line of 6th Street and the present centerline of the A.T.S.F. Railroad spur track No. 38, a point 167.97 feet West of the Southeast corner of Reserve No. 7 in the City of Lawrence, Douglas County, Kansas, thence West along the North line of 6th Street 58.85 feet, thence Northwesterly and 49.7 feet parallel with the present centerline of spur track No. 38, a distance of 59.12 feet, thence West
