PROVIDED ALWAYS, And this instrument is executed and delivered to secure the payment of the sum of - - - -

If said first parties shall cause to be paid to second party the entire amount due it hereunder and under the terms and provisions of said note hereby secured, including future advances, and any extensions or renewals hereof, in accordance with the terms and provisions thereof, and comply with all the provisions in said note and in this mortgage contained, then these presents shall be void; otherwise to remain in full force and defact, and second party shall be entitled to the immediate pos-session of all of said presents and may, at its option, declare the whole of said note due and payable and have forechosure of this mortgage or take any other legal action to protect its rights, and from the date of such default all items of indebi-dness hereunder shall draw interest at the rate of 10% per annum. Appraisement and all benefits of homestead and ex-emption laws are hereby waived.
