of the County of DOURLAS, and State of KANSAS, part y of the first part, for the purpose of this instrument hereinafter called MORTGAGOR, and KANSAS CITY THEAT, COMPANY, a Missouri Corporation, of Kansas City, Missouri, party of the second part, for the purpose of this instrument hereinafter called MORTGAGEE:

WITNESSETH: That said MORTGAGOR for and in consideration of the sum of F1f.ty Thousand and no/100 (\$50,000,00) DOLLARS, paid to said mortgagor by said mortgagee, the receipt of which is hereby acknowledged, does by these presents Grant, Bargain, Sell and Convey unto the said mortgagee, its successors and assigns, all of the following described real estate situated in the County of DOUGLAS and State of Kansas, to-wit:

Beginning at a point on the North line of Oxford Road 637 feet South and 1200.05 feet West of the center of Section 36, Township 12, Range 19, thence Hest along the North line of Oxford Road 186 feet, thence to the left on a curve of a 25 foot radius 47.58 feet to the West line of High Drive, thence along the West line of High Drive to the right on a curve of a 350 foot radius 49.17 feet, thence along the West line of High Drive to the right on a curve of a 70 foot radius 12.83 feet, thence North 100.33 feet to the South line of Cambridge Place and the West line of High Drive, thence West along the South line of Cambridge Place 195 feet, thence South 200 feet to the place of beginning; the same being further described as Lot 5 in Fraternity Quadrangle in West Hills, in Douglas County, Kansas

together with all personal property of every kind, nature and sort whatsoever, situated, or to be situated in the building or buildings located or to be located hereafter on the above described property, and used or to be used in connection with the operation of a fratenity house, as well as any and all replacements and additions to said personal property, which may be made prior to the payment in full of the indebtedness secured hereby, including therein among other items of personal property, any and all machinery, equipment, fixtures, furniture, furnishings, bedding, linens, dishes, cooking utensils, silverware, pianos, pictures and lamps; it being undertood, however, that the enumeration of any specific articles of personal property shall in nowise exclude, or be held to exclude, any items of personal property not specifically mentioned, or which may be used for purposes other than those herein mentioned.

In addition to the monthly payments of principal and interest payable under the terms of the note secured hereby, Mortgagor covenants and agrees to pay on the first day of each month until the indebtedness is, paid, 1/12 of the annual taxes and assessments lawied or to be levied against the property described herein, and 1/12 of the annual hazard insurance premium; said funds to be held in trust by theMortgages and paid by it on taxes before delinquent and on insurance premiums when due. Mortgagor further covenants and agrees that if the reserve is not sufficient take care of all items, upon notice of the amount of the deficiency it will immediately pay same to the Mortgages.
