MORTGAGE

THIS INSTRUMENT, Made this 29th day of December, 1954, by and between Alfred D. Avery and Elsie J. Avery, husband and wife of Lawrence, Kansas, Mortgagee, and National Homes Acceptance Corporation, a corporation organized and existing under the laws of Indiana, Mortgagee:

WITNESSETH, That the Mortgagee, for and in consideration of the sum of Fifty Seven Hundred and no/100-----Dollars (\$ 5700.00), the receipt of which is hereby acknowledged, does by these presents mortgage and warrant unto the Mortgagee, its successors and assigns, forever, the following-described real estate, situated in the County of Douglas State of Kansas, to wit: Lot No. Thirteen (13) Moramar Addition, City of Lawrence.
