

PARTIAL RELEASE OF MORTGAGE

Know all men by these presents, that MCPHERSON COLLEGE, a corporation, duly organized and existing under and by virtue of the laws of the State of Kansas, with its principal office at McPherson, in the State of Kansas, does hereby acknowledge that the certain instrument of mortgage, bearing date of August 22, 1950, made and executed by RUSH HOLLOWAY and HELEN HOLLOWAY, husband and wife, of Wichita, in the County of Sedgwick, State of Kansas, to MCPHERSON COLLEGE, a corporation, of McPherson, in the County of McPherson, State of Kansas, and recorded in the office of the Register of Deeds in and for the County of Douglas, State of Kansas, in Book numbered 98 of Mortgages, at page numbered 521, of the records of said office, is as to so much of the property therein described, to-wit:

A tract beginning at the Southwest corner of the Southwest Quarter (SW $\frac{1}{4}$) of Section One (1), in Township Fifteen (15), South of Range Nineteen (19), East of the Sixth Principal Meridian, thence North 1125 feet, thence East 442.5 feet, thence South 1125 feet, thence West 442.5 feet to the place of beginning, in Douglas County, Kansas

fully paid, satisfied, released, and discharged. This release is given on the express terms and conditions that it shall in no wise affect the lien of the above mentioned mortgage on the remaining land described in said mortgage, but shall only be construed as a release from the lien of said mortgage of the land above described. The said Register of Deeds is hereby authorized and directed to discharge such mortgage of record, and after the record of this instrument, to make a minute of discharge of such mortgage of record upon the margin of the records thereof, in accordance with the provisions of the statute in such case made and provided.
