1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner therein provided. Privilege is reserved to pay the debt in whole, or in an amount equal to one or more monthly payments on the principal that are next due on the note, on the first day of any month prior to maturity: *Provided, however*, that written notice of an intention to exercise such privilege is given at least thirty (30) days prior to prepayment; and *provided further* that the event the debt is paid in full prior to maturity and at that time it is insured under the provisions of the original principal amount thereof, except that in no event shall the adjusted premium exceed the aggregate amount of premium charges which would have been payable if the mortgage had continued to the least of the Rederal Housing Commissioner on account of be applied by the Grantee upon its obligation to the Federal Housing Commissioner on account of mercane.

Any deficiency in the amount of such aggregate monthly-payment shall, unless made good by the Mortgrigor prior to the due date of the next such payment, constitute an event of default under this mortgrage. The Mortgrigge may collect a "intercharge" not to exceed two cents (2c) for each dollar (81) of each payment more than fifteen (15) days in arrears to cover the extra expense involved in handling definquent payments.

3. That if the total of the payments made by the Mortgagor under (b) of paragraph 1 preceding shall exceed the amount of payments actually made by the Mortgage for ground reats, taxes and assessments or insurrice previous as the case may be, such excess shall be credited by the Mortgage on subsequent payments of the same nature to be made by the Mortgagor.
