of all incumbrances

part 1st of the first part to the said part 2nd of the second part

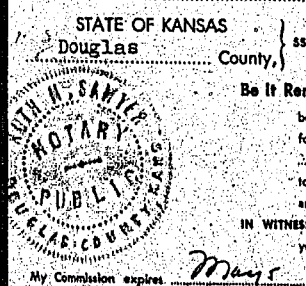

parties of the first part, their heirs and assigns.
