AFFIDAVIT OF MORTGAGE LIEN

The Northeast Quarter (NE $\frac{1}{4}$) except one (1) square acre in the Northeast corner of Section Nine (9) Township Fourteen (14) South, Range Twenty-one (21) East of the Sixth Principal Meridian, containing 159 Acres, more or less, according to the Government survey thereof.
