Hundred and fifty-six by and between Richard Harris and Rosemary

V. M. Auchard and Mildred Auchard, his wife as joint owners with right
of survivorship in either parties of the second part

Witnesseth, That said parties of the first part, for and in consideration of the sum of
Five Thousand (\$5000.00) Dollars
to them in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged, have
granted, bargained, sold, and conveyed, and by these presents do grant, bargain, sell and convey unto the said parties
of the second part and to their heirs and assigns forever, all of the following described tract, piece,
and parcel of land lying and situated in the County of Douglas and State of Kansas, to-wit:

Beginning at a point in the North Section line, 1152 feet
West of the Northeast corner of the Northeast Quarter
of the Northeast Quarter of Section No. Fourteen (14),
Township No. Thirteen (13) South, Range No. Nineteen
(19) East, thence South 312 feet, thence West 173.3 feet
more or less to the West line of the Northeast Quarter
of the Northeast Quarter of said Section, thence North
312 feet to the North line of said Section, thence East 172.8
feet more or less to the point of beginning.
