at Home State Bank, Kansas City, Mo. in monthly installments, payable as follows, to-wit:

\$42.00 (inc. int) Dollars on the 14 day of September, 1956 and

\$42.00 (inc. int) Dollars on the 14 day of each succeeding month thereafter, until

the whole sum named is fully paid with interest from this date at the rate of 6% per cent per annum. Each installment shall be first applied in payment of the interest and then on the unpaid balance of the principal sum. If default is made in payment of any installment when due, then all the remaining installments shall become due and payable at once, and bear interest at 6 per cent per annum. Privilege is given to pay two or more installments at any payment time.
