Witnesseth, That said part 1st of the first part for and in consideration of the sum of Fifteen hundred and No/100 Dollars to them in hand paid by the said parties of the second part, the receipt whereof is hereby acknowledged, have granted, bargained, sold, and conveyed, and by these presents do grant, bargain, sell and convey unto the said part 1st of the second part, and to their heirs and assigns forever all of the following described tract piece and parcel of land lying and situated in the County of Douglas and State of Kansas, to wit:
