AND WHEREAS all the requirements of law and of the charter and
by-laws of the Company, including all requisite action of directors,
and all things necessary to make said bonds, when duly executed by
the Company and authenticated and delivered by the Trustee, and
duly issued, the valid, binding and legal obligations of the Company,
and to make this Indenture a valid and binding mortgage pledge and
deed of trust for the security of all bonds from time to time issued
hereunder, in accordance with its terms, have happened, been done,
and been performed;

Now, THEREFORE, THIS TRUSTEE, WILLIAM W. GREELY, of the State of
Massachusetts, in consideration of the premises and of the mutual
covenants herein contained and of the purchase and acceptance by the
holders thereof of the bonds at any time issued hereunder, and of
One Dollar (\$1) to it duly paid by the Trustee at or before the issuing
and delivery of these presents, the receipt whereof is hereby acknowl-
edged, and in order to secure the payment of the principal of, and
interest and premium, if any, on, all bonds from time to time outstand-
ing hereunder, according to the terms of said bonds and of the coupons
annexed thereto, and to secure the performance and observance of all
the covenants and conditions therein and herein contained, and to
declare the terms and conditions upon and subject to which said bonds
are and are to be issued and secured, has executed and delivered this

Indenture and hath granted, bargained, sold, warranted, aliened,
remised, released, conveyed, assigned, transferred, mortgaged, pledged,
set over and confirmed, and by these presents doth grant, bargain, sell,
warrant, alien, remise, release, convey, assign, transfer, mortgage,
pledge, set over and confirm unto The Central Bank and Trust Com-
pany, as Trustee, and its successor or successors in the trust and its
assigns forever, the following property, to wit:

PART FIRST.

GAS DISTRIBUTION SYSTEMS AND FEE PROPERTY.

A. The gas distributing plants and systems owned by the Com-
pany, located in and adjacent to the Cities of Greeley, La Salle, Evans
and Eaton and the Towns of Aub, Platteville, Pierce, Keenesburg,
Hudson and Gilcrest, all in Weld County, State of Colorado; and

B. The gas distributing plants and systems owned by the Com-
pany, located and adjacent to the Town of Craig in Moffat County,
Colorado; and

C. The gas distributing plants and systems owned by the Com-
pany, located in and adjacent to the City of Canon City and the Towns
of South Canon and East Canon in Fremont County, all in the State of
Colorado, together with

D. All the branches and extensions of such plants and systems,
including the lands and interests in land on which the same and every
part thereof is situated, and all buildings, structures, gas mains, meters,
services, tanks, conduits, regulators, pipes, fittings, valves, connections,
and all appurtenances, appliances and equipment, and all other prop-
erty real, personal or mixed, within or without said Cities and Towns,
owned and forming a part of or owned and used, occupied, or enjoyed
in connection with or in anywise appertaining to, said distributing
plants and systems, or owned and used for the supplying of gas to any
of the patrons of the Company, and all rights of way, easements, por-
