The undersigned hereby covenant and agree that they are legal and sole owners of the real estate conveyed to F. E. Wolf by a mortgage dated Sept-ember 15, 1955 and recorded on page 155 of the Book of Mortgages No 105 of Douglas County, Kansas which mortgage was executed by Floyd R. Smith and Rosalie Smith, his wife, and given to secure the payment of a note or bond for the sum of \$3300.00, due and payable on October 1, 1953 to F. E. Wolf, on which it is hereby acknowledged there is still due and unpaid the sum of \$1132.73 of principal money, and, whereas, Floyd R. Smith and Rosalie Smith have requested that the payment of the balance of \$1132.73 of their loan not only be extended to August 1, 1963 but also have Fequested that the balance of their loan be increased to a total of \$2300.00, principal money;

Now therefore, in consideration of the agreement of F. E. Wolf to extend the time of payment of the balance of their present loan and to increase the same to a total balance of \$2300.00 as requested, the undersigned for value received hereby assume and agree to pay to the order of F.
