FOR VALUE RECEIVED, the undersigned as principals, jointly and severally promise to pay

the sum of Six Thousand Thirty-seven and 92/100 DOLLARS,
(\$ 6,037.92 84 consecutive monthly installments of \$ 71.88 each (except that the final installment shall be the difference between the

amount of this note and the sum of the preceding installments), the first to become due and payable June 8 in 64th balance of installments to be paid on the same date of each month thereafter, with interest on principal after maturing of entire balance as herein provided at the highest lawful contract rate, and 1% of the principal and interest of this note, or, at the option of the holder, a reasonable sum as attorney's fee if placed in the hands of an attorney for collection after maturity. If any installment is not paid when due, the entire balance of this note shall become due and payable at the option of the holder. Authorized FHA "late charges" (if per \$1, maximum \$5) are payable on any installment more than 15 days in arrears. The makers, endorsers and guarantors of this note waive each maker, endorser (except without recourse) and guarantor of this note hereby authorizes any attorney, probatory or clerk of court of any court of record to appear in such court, in term time or vacation, at any time after maturity of this note, and waive a jury trial and business judgment without process in favor of the holder of this note for such amount as may appear to be unpaid thereon, together with costs and attorney's fees, and waive and release all errors which may intervene on any such proceedings and consent to immediate execution upon such judgment, hereby ratifying and affirming all that may be done by virtue hereof.
