## MORTGAGORS COVENANT AND AGREE:

- To keep sold premises insured for the protection of Morfgagee in such manner, in such amounts and in such companies as Mortgagee may from time to time approve, and to keep the policies therefor, properly endorsed, on deposit with Martgagee; and that loss proceeds (less expenses of collection) shall, at Mortgagee's option, be applied on sold indebtedness, whether due or not, or to the restoration of sold improvements.
- 2. To pay all taxes and special assessments of any kind that have been or may be levied or assessed within the State of Kansao upon said premises, or any part thereof, or upon the note or debt secured hereby, or upon the interest of Martgagee in said premises or in said note or said debt, and procure and deliver to Martgage, at its home office, ten days before the day fixed by law for the first interest or penalty to accrue thereon, the official receipt of the proper officer showing payment of all such taxes and assessments.
- To keep said premises free from all prior liens and upon demand of Mortgagee to pay and procure release of any lien which in any way may impair the security of this mortgage.
- 4. In the event of default by Mortgagors under paragraphs 1, 2 or 3 above; Mortgagee, at its option (whather electing to declare the whole indebtedness hereby secured due and collectible or not), may (a) effect the insurance above provided for and pay the reasonable premiums and charges therefor; (b) pay all soid taxes and assessments without determining the validity thereof (unless Mortgagors have instituted proper legal proceedings to test the validity of such taxes and assessments and have deposited with Mortgagee security therefor acceptable to it); and (c) pay such liens, and all costs and expenses herein covenanted to be paid by Mortgagors; and all such disbursements, with Interest thereon from the time of payment at the highest rate allowed by law, shall be deemed a part of the indebtedness secured by this mortgage and shall be immediately due and payable by Mortgagors to Martgagee.
- 5. To keep the buildings and other improvements now or hereafter erected in good condition and repair, not to commit or suffer any waste or any use of sold premises contrary to restrictions of record or contrary to laws, ordinances or regulations of proper public authority, not to remodel the improvements for other than residence use, not to assign or pledge any lease of the premises and not to procure or accept prepayment of rent for more than one month unless with the written cansent of Mortgagee, and to permit Mortgagee to enter at all reasonable times for the purpose of inspecting the premises.
- 6. That they will pay the indebtedness hereby secured promptly and in full compliance with the terms of sold note and this martgage, and that the time of payment of soid indebtedness, or of any portion thereof, may be extended or renewed, and any portions of the premises herein described may, without notice, be released from the lien hereof, without releasing or affecting the personal liability of any person or corporation for the payment of soid indebtedness or the lien of this instrument upon the remainder of soid premises for the full amount of soid indebtedness then remaining unpoid, and no change in the ownership of soid premises shall release, reduce or otherwise affect any such personal liability or the lien hereby created.

## IT IS MUTUALLY AGREED THAT:

- In case default shall be made in the payment of any instalment of said note or of interest thereon when due or if there shall be a failure on the part of Mortgagors to comply with any covenant, condition or provision of this mortgage, then the said note and the whole indebtedness secured by this mortgage, including all payments for taxes, assessments, insurance premiums, liens, costs and expenses herein specified shall, at the option of Mortgagee and without notice to Mortgagors (such notice being hereby expressly waived), become due and collectible at once by foreclosure or otherwise.
- 2. As further security for the fulfilliment of Mortgagors' obligations, Mortgagors hereby assign to Mortgage all present and future leases and hereby grant Mortgage the right, power and authority to collect all rents, issues and profits of the premises, including but not limited to any oil, gos and mineral leases gind any bonus, rents and royalties payable theseunder, and upon any default. Mortgage is hereby empowered to enter upon and take possession of the premises, to let the some, to receive all rents, issues and profits thereof either due or to become due and to apply such receipts in payment of necessary charges and expenses and, on a occount of said indebtedness, and Mortgage's acts, as authorized in this paragraph, shall not in any way affect its rights of foreclosure and appointment of a receiver, or other rights of enforcement, as hereinafter provided.
- 3. If the note and mortgage, or either of them, shall be placed in the hands of an attorney for collection or foreclosure, or if Mortgagee voluntarily or involuntarily becomes or is made a party to any suit orproceeding relating to the premises or to this mortgage or soid note, Mortgagers shall reimburse Mortgagee for its reasonable costs and for expense of procuring abstracts or other evidences of title and title insurance in connection therewith.
- 4. If any proceedings shall be brought to foreclose this mortgage or to collect the indebtedness hereby secured, Mortgagee shall be entitled as a matter of right, without notice to Mortgagors or any person claiming under them and without regard to the adequacy of the security or whether the same shall then be occupied by the owner of the equity of redemption as a homestead, to the immediate oppointment of a receiver with power to take possession of the premises, lease the same, collect oil rentals and profits thereof and hold and apply the receipts as the court may order for maintenance of the security and an account of sold indebtedness.
- 5. Mortgagee shall be subrogated to the lien of any and all prior incumbrances, liens or charges paid and discharged from the proceeds of the note hereby secured, and even though sold prior liens have been released of record, the repownent of said note shall be secured by such liens on the portions of said premises affected thereby to the extent of such payments, respectively.

6. Whenever by the terms of this instrument or of said note Mortgagée is given any option, such option may be exercised when the right accrues, or at any time thereafter.
