PARTIAL RELEASE OF REAL ESTATE MORTGAGE

For and in consideration of the sum of One Dollar (\$1.00) and other valuable consideration, the receipt whereof is hereby acknowledged, the Federal Land Bank of Wichita, Wichita, Kansas, a corporation, (hereinafter referred to as the Bank) does

hereby release and discharge the following described real estate situated in Douglas County, State of Kansas, to-wit:

Beginning at the Southwest Corner of the E $\frac{1}{2}$ of NE $\frac{1}{4}$ of Section 34, Township 12 South, Range 19 East of the 6th Principal Meridian, then 53 rods North and 10 rods East to point of beginning; then 16 rods South and 10 rods East, then 16 rods North, then 10 rods West to point of beginning.

Containing 1 acre, more or less.

from the lien of that certain real estate mortgage dated the 3rd day of March, 1952, executed by Clifford W. Davenport and Mary K. Davenport, his wife,

as mortgagor(s), in favor of the Bank, as mortgagee, which said mortgage is recorded in Book 101 at Page 455, of the mortgage records of said County. Provided, however, and it is expressly agreed and understood, that the lien of said mortgage is hereby retained upon all of the other property covered thereby, not specifically described herein; and that the execution of this partial release shall not affect, in any manner, the validity or priority of said mortgage as a lien upon such other property.
