MORTGAGE

THIS INDENTURE, made as of this 1st day of December, 1959 by
Archie D. Jameson
 and his wife, Doris A. Jameson of
Eudora Douglas County, Kansas hereinafter
 (Address) (City)
 designated as Mortgagor (whether one or more), to Phillips Petroleum Company, a Delaware corpora-
 tion, having a place of business and post office address at Phillips Building, Bartlesville, Washington
 County, State of Oklahoma, hereinafter designated as Mortgagee,

WITNESSETH:

WHEREAS, Mortgagor has executed and delivered to the First National Bank in Bartlesville, Bartlesville,
 Oklahoma, Trustee, a certain promissory note, a copy of which is attached hereto and by this reference made
 a part hereof as if herein set forth at length, and

WHEREAS, the loan evidenced by said promissory note would not have been made by said bank but
 for a commitment by Mortgagee to the payee of said promissory note with respect to the purchase of
 said promissory note.

Now, THEREFORE, in consideration of the premises and of the sum of One Dollar (\$1.00), and
 other valuable consideration, to the undersigned Mortgagor in hand paid by Mortgagee, the receipt and
 sufficiency of which is hereby acknowledged, and for the purpose of inducing Mortgagee to make to said
 bank the commitment aforesaid and to secure such commitment and the prompt payment of said
 promissory note according to its terms and conditions upon and after the purchase thereof by Mortgagee,
 whether such purchase be pursuant to its said commitment or for other reason, Mortgagor does hereby
 grant, bargain, sell, assign, convey, mortgage and warrant unto Mortgagee the following described real
 property in the County of Douglas State of Kansas to wit:

Beginning at a point on the east line of Block 43, Eudora,
 Kansas, said point being 50 feet south of the center line
 of 10th Street; thence south on the east line of said
 Block 43 a distance of 82.0 feet; thence west on a line
 parallel to the center line of 10th Street a distance of
 200.0 feet; thence north on a line parallel to the east
 line of Block 43 a distance of 82.0 feet; thence east a dis-
 tance of 200.0 feet to the point of beginning.
