TO HAVE AND TO HOLD THE SAME, With all and singular the tenements, hereditaments and appurtenances there-nto belonging, or in anywise appertaining, forever, and hereby warrant the title to the same.

It is agreed that the mortgagee, may, at any time during the mortgage term, end in its discretion, apply for and purchase mortgage guaranty insurance, and may apply for relevant of such mortgage guaranty insurance covering this mortgage, and pay premiums due by esseen thereof, and require relayment by the mortgagers of such amounts as are advanced by the mortgage. This mortgage shall remain in full force and effect between the parties hereto and their heirs, personal representatives, uncessors and assigns, until all amounts due hereunder, including future advancements, are paid in full, with interest; and upon the maturing of the present indebtedness for any cause, the total debt on any such additional loans shall at the same time and for the same specified causes be considered matured and draw ten per cent interest and be collectible out of the proceeds of sale through forcelosure or otherwise.

First parties agree to keep and maintain the buildings now on said premises or which may be hereafter erected thereon in good condition at all times, and not suffer waste or permit a nuisance thereon. First parties also agree to pay all taxes, assessments and insurance premiums as required by second party.

First parties also agree to pay all costs, charges and expenses reasonably incurred or paid at any time by second party, including abstract expenses, because of the failure of first parties to perform or comply with the provisions in said note and in this mortgage contained, and the same are hereby secured by this mortgage.

First parties hereby assign to second party the rents and income arising at any and all times from the property mortgaged to secure this note, and hereby authorize second party or its agent, at its option upon default, to take charge of said property and collect all rents and income and apply the rame on the payment of insurance premisms, taxes, assessments, repairs or improvements necessary to keep said property in tenantable condition, or other charges or payments provided for in this mortgage or in the note hereby secured. This assignment of rents shall continue in force until the unpaid balance of said note is fully paid. It is also agreed that the taking of possession hereunder shall in no manner prevent or retard second party in the collection of said sums by foreclosure or otherwise.

The failure of second party to assert any of its right hereunder at any time shall not be construed as a waiver of its right to assert the same at a later time, and to insist upon and enforce strict compliance with all the terms and provisions in said note and in this mortgage contained.

If said first parties shall cause to be paid to second party the entire amount due it hereunder and under the terms and provisions of said note hereby secured, including future advances, and any extensions or renewals hereof, in accordance with the terms and provisions thereof, and comply with all the provisions in said note and in this mortgage contained, then these presents shall be void; otherwise to remain in full force and effect, and second party shall be meritied to the immediate possion of all of said premises and may, at its option, declare the whole of said note due and appayable and have foreclosure of this mortgage or take any other legal action to protect its rights, and from the date of such default all items of indebteneption laws are hereby waived.
