WITNESSETH: That said first parties, in consideration of the loan of the sum of Thirteen Thousand Five Hundred and No/100-----

made to them by second party, the receipt of which is hereby acknowledged, do by these presents mortgage and warrant unto said second party, its successors and assigns, all of the following-described real estate situated in the County of Douglas and State of Kansas, to-wit:

Beginning at a point 235 feet South of the Northwest corner of the Southeast Quarter of Section 5, Township 13 South, Range 20 East of the Sixth Principal Meridian; thence South 95 feet; thence East 917.05 feet; thence North 95 feet; thence West 917.05 feet to the place of beginning, containing 2 acres, more or less; Douglas County, Kansas

(It is understood and agreed that this is a purchase money mortgage.)

Together with all heating, lighting, and plumbing equipment and fixtures, including stokers and burners, screens, awnings, storm windows and doors, and window shades or blinds, used on or in connection with said property, whether the same are now located on said property or hereafter placed thereon.

PROVIDED ALWAYS, And this instrument is executed and delivered to secure the payment of the sum of Thirteen Thousand Five Hundred and No/100-----

with interest thereon, advanced by said Capitol Federal Savings and Loan Association, and such charges as may become due to said second party under the terms and conditions of the note secured hereby, which note is by this reference made a part hereof, to be repaid as follows:
