

And upon forfeiture of this Mortgage, or in case of default in any of the payments herein provided for, the second party its XXX, successors and assigns, shall be entitled to a judgment for the sum due upon said note, and the additional sum paid by virtue of this Mortgage, with interest on said additional sum so paid at the rate of ten per cent, per annum from the date of payment of said sum, and costs, and a decree for the sale of said premises in satisfaction of said judgment, foreclosing all rights and equities in and to said premises of the said first party its XXX, successors, and assigns, and all persons claiming under it.

And the said first party Y shall and will at its own expense from the date of the execution of this Mortgage until paid more and interest, and all liens and charges by virtue hereof are fully paid off and discharged, keep the building erected and to be erected on said lands, insured to some responsible insurance company duly authorized to do business in the State of Kansas, to the amount of Twelve Thousand Five Hundred dollars, for the benefit of said second party, and in default thereof said second party Y may effect said insurance in its own name, and the premium or premiums, costs, charges and expenses for effecting the same shall be an additional lien on said mortgaged property, and may be enforced and collected in the same manner as the principal debt hereby secured.

And the said first party Y do hereby covenant and agree that at the delivery hereof it is the lawful owner of the premises above granted, and seized of a good and indefeasible estate of inheritance therein, free and clear of all incumbrances, and that it will Warrant and Defend the same in the quiet and peaceable possession of said second party Y, its successors and assigns forever, against the lawful claims of all persons whomsoever.
