SUPPLEMENTAL MORTGAGE OF PROPERTY, dated the first day of August, 1960, made by MID-AMERICA PIPELINE COMPANY, a corporation duly organized and existing under the laws of the State of Delaware and having its principal office at 1437 South Boulder Avenue, Tulsa 19, Oklahoma (hereinafter called the "Company");

WHEREAS the Company has heretofore duly executed and delivered a Mortgage and Deed of Trust, dated May 1, 1960, to BANKERS TRUST COMPANY, a corporation duly organized and existing under the laws of the State of New York, and having its principal office at 16 Wall Street, New York 15, New York and Ford W. Hardin, residing at 6348 Washington Avenue, University City 30, Missouri, as Trustees (hereinafter referred to as the "Original Indenture"), whereby all the properties of the Company whether owned at the time of the execution thereof or thereafter acquired, other than excepted property as therein defined and set forth, were granted, assigned, conveyed, transferred, mortgaged, and pledged to the Trustees in trust upon the terms and conditions set forth therein to secure bonds of the Company issued and to be issued in accordance with the terms of the Original Indenture as it may from time to time be supplemented, modified or amended (the Original Indenture as heretofore supplemented, modified or amended being hereinafter referred to as the "Indenture"); and

WHEREAS the Original Indenture has been recorded in the counties of the states of Texas, New Mexico, Oklahoma, Kansas, Nebraska, Missouri, Iowa, Minnesota, Illinois and Wisconsin as specified and described in Exhibit A hereto annexed and hereby made a part hereof;

WHEREAS the Original Indenture has heretofore been supplemented by eight duly executed Supplemental Mortgages of Property, each dated June 1, 1960, pursuant to §§ 402, 612 and 1601 of the Original Indenture, and respectively duly recorded in applicable counties of the states of Texas, New Mexico, Oklahoma, Kansas, Nebraska, Missouri, Iowa and Minnesota which are referred to in Exhibit B to each of said Supplemental Mortgages of Property; and
