TO HAVE AND TO HOLD THE SAME, Together with all and singular the tenements, hereditaments and appurtenances thereunto belonging, or in anywise appertaining forever:  
PROVIDED ALWAYS, and these presents are upon this express condition, that whereas said Richard A. Daigh and Marjorie A. Daigh, his wife have on this day executed and delivered one certain promissory note to said parties of the second part, for the sum of Three Thousand Eight Hundred Sixty (\$3,860.00) and no/100 DOLLARS bearing even date herewith, payable at their office in Lawrence, Kansas, in equal installments of Twenty and no/100 (\$20.00) DOLLARS each, the first installment payable on the 1st day of September, 19 60, the second installment on the 1st day of October, 19 60, and successing installments on the first day of each and every month in each year thereafter, until the entire sum is fully paid.
