WITNESSETH, That the said parties of the first part, in consideration of the sum of Fifty Five Hundred (\$5500.00) DOLLARS, to them duly paid, the receipt of which is hereby acknowledged, have sold and by these presents do grant, bargain, sell and mortgage to the said parties of the second part, their heirs and assigns, forever, all that tract or parcel of land situated in the County of Douglas,

and State of Kansas, described as follows, to wit:

with the appurtenances, and all the estates, title and interest of the said part in the first part therein. And the said

do hereby covenant and agree that at the delivery hereof they are the lawful owner of the premises above granted, and seized of a good and indefeasible estate of inheritance therein, free and clear of all incumbrances,

and that they will warrant and defend the same against all claims whatsoever. This grant is intended as a Mortgage to secure the payment of the sum of Fifty Five Hundred (\$5500.00) DOLLARS, according to the terms of one certain promissory note this day executed by the said parties of the first part to the said parties of the second part;

said note being given for the sum of Fifty Five Hundred DOLLARS, dated 12th day of October 1960, due and payable in one year from date hereof,

with interest thereon from the date thereof until paid, according to the terms of said note and coupons thereto attached.

And this conveyance shall be void if such payment is made as in said note and coupons thereto attached, and as hereinbefore specified. And the said party of the first part hereby agrees to pay all taxes assessed on said premises before any penalties or costs shall accrue on account thereof, and to keep the said premises insured in favor of said mortgagee in the sum of \$8000.00 DOLLARS, in some insurance company satisfactory to said mortgagee, in default whereof the said mortgagee may pay the taxes and accruing penalties, interest and costs, and insure the same at the expense of the party of the first part; and the expense of such taxes and accruing penalties, interest and costs, and insurance, shall from the payment thereof become an additional item under this mortgage upon the above-described premises, and shall bear interest at the rate of ten per cent, per annum, until it shall be made, such payments or any part thereof, or interest thereon, or the taxes assessed on said premises, or if the insurance is not kept up thereon, then the same shall become due, and the whole principal of said note, and interest thereon, and all taxes and accruing penalties and interest and costs thereon remaining unpaid or which may have accrued, and all sums paid by the party of the second part for insurance, shall be due and payable, or not, at the option of the party of the second part, and all sums paid by the party of the second part for insurance, shall be due and payable, or not, executors and administrators and assigns, at any time thereafter, to sell the premises hereby granted, or any part thereof, in the manner prescribed by law—appraisement hereby waived or not, at the option of the party of the second part, executors, administrators, or assigns; and out of all the moneys arising from such sale to retain the amount then due or to become due according to the conditions of this instrument, together with the costs and charges of making such sale, and the overplus, if any there be, shall be paid by the party of the second part making such sale, on demand, to the said
