RELEASE OF MORTGAGE BY ASSIGNEE

The First National Bank of Lawrence, Kansas, the assignee, by an Assignment dated May 24, 1955, recorded May 25, 1955, in Book 109 at Page 417 in the office of the Register of Deeds of Douglas County, Kansas, of the mortgage for \$20,000.00 wherein Joseph C. Roberts and Effie C. Roberts, his wife, were mortgagors, and Leo C. Rosa and Lorene M. 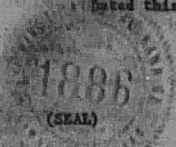

M.; thence North 165 feet; thence West to the railroad right of way; thence South to the South line of said Quarter Section; thence East to the place of beginning.

And The First National Bank of Lawrence, Kansas, as assignee, by an Assignment dated December 27, 1957, recorded December 27, 1957, in Book 199 at Page 438 in the office of the Register of Deeds of Douglas County, Kansas, of the said mortgage for \$20,000.00 above described, does hereby acknowledge the satisfaction of said mortgage; the note and indebtedness thereby secured having been settled and paid in full, the Register of Deeds of Douglas County, Kansas, is hereby authorized and directed to discharge such mortgage of record, and after the record of this instrument, to make a minute of the discharge of such mortgage of record upon the margin of the record thereof, in accordance with the provisions of the statute in such case made and provided.

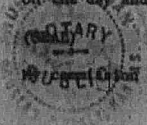
