- NOW THEREFORE, in consideration of the premises and of the sum of One Dollar (\$1,00) to the underrigned, Harris Trust and Savings Bank, Trustes, paid receipt whereof is hereby acknowledged, and pursuant to the request of Company the underrigned, as Trustee as aforesaid, has remised, released, and does quitclaim unto said The Kansas Power and Light Company and to its successors and assigns, all right, title, interest, claim, and demand which the underrigned, as Trustee as aforesaid, may have acquired under and by virtues of said Indenture, and any and all indentures supplemental thereto, in and to the following described real state and the office building thereon, situated in Douglas County, Kansas, to-wit:

West Seventy-sight and three quarters (78-3/4) feet of Lot Twenty-two (22) on Massachusetts Street in the City of Lawrence.

This release, however, shall not include any property other than that specifically described herein, all other property of Company remaining subject to the lies of said Indenture dated July 1, 1939, and Indentures supplemental thereto, as heretofore.

The Indenture may be executed in any number of counterparts, each of which shall for all purposes be deemed to be an original.
