PARTIAL RELEASE OF REAL ESTATE MORTGAGE

Beginning at the Northeast corner of Section 34 in Township 12 South, Range 19 East of the 6th Principal Meridian, thence west 1 rod and 58 rods south; thence 1 rod west and 45 rods south; thence 78 rods west and 125 rods south; thence 80 rods east and 38 rods north; thence 297 feet west and 438 feet north; thence 297 feet east and 950 feet northwest; thence 526.64 feet east; thence north to point of beginning.
