sold, and conveyed, and by these presents does grant, bargain, sell and convey unto the said party of the second part and to his

said party of the second part, and to his heirs and assigns forever; PROVIDED ALWAYS, and this instrument is made, exe-
cuted, and delivered upon the following conditions, to-wit:

At the dates hereinafter mentioned, for value received, I, W. E. Owen, jointly and severally, promise to pay to
the order of Asarco Roofing and Siding Company

the sum of TWENTY THREE HUNDRED NINETY FOUR AND 60/100 Dollars

in 60 successive monthly installments of \$ 22.91 each (except that the final installment shall be the difference

between the amount of this note and the sum of the preceding installments) commencing on the 26 day of June 19 61
and on the same day of each and every month thereafter until paid in full, with interest at the rate of 8 per cent per annum after
maturity; and agree that on default in the payment of any installment the whole amount of this note shall then and there become
due at the election of the holder thereof.

I, W. E. Owen, agree to pay a "late charge" not to exceed 5% per month for each payment more than ten days in arrears, to cover
the extra expense involved in following up and handling delinquent payments.

The makers, endorsers, guarantors and assignors of this note, jointly and severally, do hereby waive demand, presentment for
payment, notice of non-payment and protest, and do each hereby waive notice of and consent to any and all extensions of this
note or any part thereof from time to time without notice to us, and hereby waive any and all notice of whatsoever kind or
nature, and waive the exhaustion of legal remedies hereon.

And further to secure the payment of said amount, the undersigned hereby jointly and severally irrevocably authorize and
empower any attorney of any Court of Record to appear for them or either of them, in such court or any time hereafter and con-
fess a judgment without process against them or any one or more of them, in favor of the legal holder of this note, for such sum
as may appear to be unpaid and owing thereon, together with interest, costs and reasonable attorney's fees, and to waive and
release all errors which may intervene in such proceeding, and consent to immediate execution upon such judgment, hereby rat-
ifying and confirming all that said attorney may do by virtue hereof.
