KNOW ALL MEN BY THESE PRESENTS THAT:

WHEREAS, Union Pacific Railroad Company, a corporation organized under the laws of the State of Utah, as party of the first part, and The Mercantile Trust Company, a corporation organized under the laws of the State of New York, as Trustee, as party of the second part, executed a certain indenture of mortgage dated July 1, 1897 (hereinafter called the "Mortgage"); and

WHEREAS, Union Pacific Railroad Company and The Mercantile Trust Company, as Trustee, also executed a certain instrument dated June 30, 1898 for the purpose of prescribing and defining the conditions and provisions subject to which certain bonds and stock of The Union Pacific Land Company, a corporation organized under the laws of the State of Utah, were pledged with and delivered to the Trustee; and

WHEREAS, The Mercantile Trust Company was on August 10, 1911 merged into Bankers Trust Company under the laws of the State of New York, and thereby all and singular the rights, franchises and interests of The Mercantile Trust Company in and to every species of property, real, personal and mixed, and things in action thereunto belonging, were transferred to and vested in Bankers Trust Company, and Bankers Trust Company has succeeded to all relations, obligations, trusts and liabilities of The Mercantile Trust Company, and has assumed the performance of all trusts of The Mercantile Trust Company, including the trusts under the Mortgage and is now the duly constituted Trustee under the Mortgage; and

WHEREAS, Union Pacific Railroad Company, as party of the first part, and Bankers Trust Company, a corporation organized under the laws of the State of New York, as Trustee (succeeding The Mercantile Trust Company),
