This Indenture, Made this First day of September in the year of our Lord one thousand and eight hundred and eighty six between Malita J. Bailey and John J. Bailey her husband (being of law-
ful age), of the County of Douglas and State of Kansas, of the first part; and Edward Russell of Lawrence, Kansas of the second part,

Witnesseth, That the said parties of the first part, in con-
sideration of the sum of Seven Hundred and Twenty Dollars,
to them in hand paid, the receipt whereof is hereby acknowled-
ged, have sold, and by these presents do grant, bargain, sell and
convey to the said party of the second part his heirs and as-
signs forever, the following tract or parcel of land situated in
the County of Douglas and State of Kansas, described as follows,
to wit: Lots fifteen(15) and sixteen(16) of Block eight(8)
in Leaven's first addition to Lawrence. The parties of the
first part reserve the right to pay \$100.00 or any multiple
thereof after two years, such payment to be made at any inter-
est payment, and being the same lands conveyed to Malita
Bailey by deed from Thomas W. Harris and others dated August
Twenty second A.D. 1883. Recorded August 23, 1883. Douglas
County Records Deeds Book 22 on page 108. with the appurten-
ances all the estate, title and interest of the said parties of the
first part therein. And the said parties of the first part do hereby
covenant and agree that at the delivery hereof they are the law-
ful owners of the premises above granted, and seized of a good
and indefeasible estate of inheritance therein, free and clear
of all incumbrances; that they have good right to sell and con-
vey said premises, and that they will warrant and defend the
same against the lawful claims of all persons.

This grant is intended as a Mortgage to secure the payment
of the sum of Seven hundred and Twenty Dollars and interest
thereon, according to the terms of one certain mortgage note
and ten interest notes or coupons, this day executed by the said
Malita J. Bailey, to-wit:
