and Rebecca J. Williams, his wife, of the County of
Douglas and State of Kansas, party of the first part,
and The National Loan and Trust Company, of Topeka,
Kansas, party of the second part;

Witnesseth, That the said party of the first
part, for and in consideration of the sum of
Fifteen Hundred ⁰⁰/₁₀₀ Dollars, to them in hand paid
by the said party of the second part, the receipt
whereof is hereby acknowledged, have granted, bargained
and sold, and by these presents do grant, bargain,
sell, convey and confirm unto the said party of
the second part, its representatives or assigns forever
all of the following described tract, piece or
parcels of land lying and situate in the County
of Douglas and State of Kansas, to-wit:

The North Half of the North East quarter of
section Nineteen (19) less a strip in the North West
corner Fifty Two (52) rods East and West and
Seven (7) rods North and South, also the West Half
