At all times when the note is held by an insured lender, Borrower shall continue to make payments on the note to the Government, as collection agent for the holder. (2) To pay to the Government any initial fees for inspection and appraisal, and any delinquency charges, now recaller required by regulations of the Farmers Home Administration. for h

(3) At all times when the note is held by an insured lender, any amount due and unpaid under the terms of the note, less the amount of the annual charge, may be paid by the Government to the holder of the note as provided in the note and insurance ender the terms of the note and insurance and by the Government of by an insured lender, may be credited by the Government or the note and intervence and anguit use an advance by the Government as described in this paragraph shall bear interest at the note rate from the dateon which the advance was due to the date of payment to the Government.

(4) Whether or not the note is insured by the Government, the Government may at any time pay any other amounts required herein to be paid by Borrower and not paid by him when due, as well as any costs and expenses for the preservation, protection, or enforcement of this lien, as advances for the account of Borrower. All sight, advances shall bear interest at the note rate until paid to the Government.

(5) All advances by the Government as described in this instrument, with interest, shall be immediately due and payable by Borrower to the Government without demand at the place designated in the note and shall be secured here-by. (9) To maintain improvements in good repair and make repairs required by the Government; operate the property in a good and husbandmanlike manner; comply with such farm conservation practices and farm and home man agreenent plans as the Government from time to time may prescribe; and not to abandon the property or cause of permit waste, lessening or impairment of the security covered hereby, or; without the written consent of the Government, out, remove, or lease any timber, gravel, oil, gas, coal, or other minerals except as may be necessary for ordinary domestic purposes.

b < (10) If this instrument is given for a "Farm Ownership" loan as identified in Farmers Home Administration regulations, personally to operate the property with his own and his family labor as a farm and for no other pur-pose, and not to lease the property or any part of it, unless the Government consents in writing to some other method of operation or to a lease.

(11). To comply with all laws, ordinances, and regulations affecting the property.

(14) At all reasonable times the Government and its agents may inspect the property to uscertain whether the convenants and agreements contained herein or in any supplementary agreement are being performed.
