The Bonds of said Series 1961B, other than fully repaid Bonds, shall be in coupon form, in the denomination of \$1,000 each, numbered from 1B upwards; shall be designated "Trustees of the Baker University and Kansas Educational Association of the

Methodist Episcopal Church Student Housing System Bond, Series 1961B," dated as of October 1, 1961, and shall bear interest at the rate of Two and seven eighths per cent (2 7/8%) per annum until payment of the principal amount, payable semiannually on April 1 and October 1 in each year commencing April 1, 1962, but until maturity of said Bonds only, upon presentation and surrender of the respective coupons for such interest. Both the principal of and interest on the Bonds shall be payable at the office of the Trustee, or, at the option of the holder thereof, at Morgan Guaranty Trust Company of New York, in the Borough of Manhattan, City and State of New York, in such coin or currency of the United States of America as may be on the respective dates of payment thereof, legal tender for the payment of debts due the United States of America, and shall mature serially on October 1 in each of the years and in the amounts as follows:
