PARTIAL RELEASE OF LIEN OF TRUST INDENTURE DATED JULY 1, 1939 AND INDENTURES SUPPLEMENTAL THERETO OF THE KANSAS FOWER AND LIGHT COMPANY

ENOW ALL MEN BY THESE PRESENTS:

MERENS, The Mansas Power and Light Company, a corporation organised and exist-ing under and by virtue of the laws of the State of Kansas and having its principal of-file in the City of Topein, Kansas (hereinafter called "Company"), on or about July 1, 1939, made, executed, acknowledged and delivered to Harris Trust and Savings Bank, a corporation organised and existing under the laws of the State of Hilmois and having its principal offices and place of business in the City of Chicago, Hilmois, as Trus-er portation organized and place of business in the City of Chicago, Hilmois, as Trus-ta principal offices and place of Trust dated as of July 1, 1939 (hereinafter called "Indenture"), to secure First Mortgage Bonds of the Company issued and to be issued thereunder, which Indenture was filed for record in the Office of the Register of Deeds to Touplas County, Kansas, on November 17, 1949, as a real estate mortgage in Book 97, age 1, and as a chattel mortgage in Book 4737, as amended by various and sundry supple-sures and record thereof as aforesaid reference is hereby made; and

WHEREAS, Company has sold and conveyed the property hereinafter described and has complied with the requirements of said Indenture and is entitled to the release of said property from the lien thereof.

NOW THEREFORE, in consideration of the premises and of the sum of One Dollar (\$1.00) to the undersigned, Harris Trust and Savings Bank, Trustee, paid receipt where-of is hereby acknowledged, and pursuant to the request of Company, the undersigned, as Trustee as aforeseid, has remised, released, and does quitclaim unto said The Kansas Fower and Light Company and to its successors and assigns, all right, title, interest, claim, and demand which the undersigned, as Trustee as aforesaid, may have acquired under and by virtue of said Indenture, and any and all indentures supplemental thereto, in and to the following described real estate situated in Douglas County, Kansas, to-

Lots Ninety-eight (98), One Hundred (100) and One Hundred Two (102) on Tennessee Street, Lawrence Original Town Site.

This release, howaver, shall not include any property other than that specifi-cally described herein, all other property of Company remaining subject to the lien of said Indenture dated July 1, 1939, and Indentures supplemental thereto, as heretofore.

The Indenture may be executed in any number of counterparts, each of which shall for all purposes be deemed to be an original.
