7. To reimburse mortgagee for all costs and expenses incurred by it in any suit to foreclose this mortgage, or in any suit in which mortgagee may be obliged to defend or protect its rights or lien acquired hereunder, including all abstract fees, court costs, a reasonable attorney fee where allowed by law, and other expenses; and such sums shall be secured hereby and included in any decree of foreclosure. This mortgage is subject to the Federal Farm Loan Act and all acts amendatory thereof or supplementary thereto. The transfer and conveyance hereunder to the mortgage deformentioned payments shall be co In the event of foreclosure of this mortgage, mortgagee shall be entitled to have a receiver appointed by the court to take assistion and control of the premises described herein and collect the rents, issues and profits thereof; the amounts so collected such receiver to be applied under the direction of the court to the payment of any judgment rendered or amount found due In the event mortgager defaults with respect to any covenant or condition hereof, then, at the option of mortgagee, the indebtedness secured hereby shall forthwith become due and payable and bear interest at the rate of six per cent per annum and this mortgage shall become subject to foreclosure: Provided, however, mortgagee may at its option and without notice annul any such acceleration but no such annulment shall affect any subsequent breach of the covenants and conditions hereof. Mortgagor hereby waives notice of election to declare the whole debt due as herein provided, and also the benefit of all valuation, homestead and appraisement laws. The covenants and agreements herein contained shall extend to and be binding upon the heirs, executors, administrators, successors and assigns of the respective parties hereto.
