First parties hereby assign to second party the rents and income arising at any and all times from the property me gaged to secure this note, and hereby authorize second party or its agent, at its option upon default, to take charge of s property and collect all rents and income and apply the same on the payment of insurance premiums, taxes, assessments, pairs or improvements necessary to keep said property in tenantable condition, or other charges or payments provided in this mortgage or in the note hereby secured. This assignment of rents shall continue in force until the unpaid bala of said note is fully paid. It is also agreed that the taking of possession hereunder shall in no manner prevent or retrieved in the collection of said sums by forcelosure or otherwise.
