WITNESSETH, That the said party of the first part, in consideration of the sum of

One Hundred Twenty Seven Thousand Five Hundred and no/100 DOLLARS

to them duly paid, the receipt of which is hereby acknowledged, has sold, and by these presents does Grant, Bargain,

Sell and Mortgage to the said party of the second part, Its Successors

and assigns forever, all that tract or

parcel of land situated in the county of Douglas Jefferson and State of Kansas, described as follows, to-wit:

The West Half of the Northeast Quarter of Section Thirty-six, Township 10, Range 17, and The North Half of the Northeast Quarter of Section Thirty-five, Township 10, Range 17, and The Northwest Quarter of the Northwest Quarter of Section Thirty-six, Township 10, Range 17, and The Southwest Quarter of the Southwest Quarter of Section Twenty-five, Township 10, Range Seventeen, and The North Half of the Lot Four in Northeast Quarter of the Northwest Quarter of Section Thirty-five, Township 10, Range Seventeen, containing Fourteen and Forty hundredths (14.40) acres, more or less.
 Also Lot 2 and the west half of the South-west Quarter of Section 26, Township 10 South, Range 17 East; also beginning at the Southeast corner of Lot 1 per government plat and survey of the Northwest fractional quarter of section 26, township 10, range 17 Delaware Trust Lands, and run thence West along the South line thereof 16.70 Chains to a small branch or creek, thence in a northerly direction along said branch to where it intersects Rockcreek, thence down the center of said Rockcreek following the meanderings thereof to where it intersects the east line of lot 1, thence south along said east line of lot 1, to the place of beginning, containing 19.30 acres, more or less: all the land described herewith to be 151.60 acres, more or less in Jefferson County, Kansas.
 Also The Northeast Quarter of Section 2, Township 12, and Range Nineteen less the right of way of the Union Pacific Railroad; also the North 1/3 of the West Half of the Southeast Quarter and the North 1/3 of the East fractional half of the Southwest Quarter of Section 2, Township 12, Range Ninteen all the East of the Sixth principal Meridian; also beginning at a point on the East and West center line of Section Two and 1370.5 feet East of the West line of Section Two: thence S.0°30"E, 680 feet; thence 450 feet East parallel to the East and West center line of Section Two; thence 10°30"W, 680 feet to a point on the East and West center line of Section Two: thence West on the East and West center line of Section Two 450 feet to the place of beginning and containing 9.1 acres, more or less.
