THIS INDENTURE, Made this 3rd day of November, 1964, between The Lawrence Country Club, a corporation duly organized, incorporated and existing under and by virtue of the laws of the State of Kansas and having its principal place of business at Lawrence, Kansas, party of the first part, and The Lawrence National Bank of Lawrence, Kansas, a corporation, party of the second part;

WITNESSETH, That the said party of the first part, in consideration of the sum of Twenty-Eight Thousand Dollars (\$28,000.00) to it duly paid, the receipt of which is hereby acknowledged, has sold and by this indenture does grant, bargain, sell and mortgage to the said party of the second part, the following described real property situated and being in the County of Douglas and State of Kansas, to wit:

(1) The North Half of the Southeast Quarter of Section Twenty-six, Twp. 12, Rng. 19, except the following described property deeded August 30, 1895, to Henry S.
