a body corporate, existing under and by virtue of the laws of Missouri, and having its chief office in the City of  
Kansas City, State of Missouri, hereinafter called Mortgagee.

Witnesseth: That whereas Mortgagor is justly indebted to Mortgagee for money borrowed in the principal sum of

EIGHTEEN THOUSAND and No/100 DOLLARS,
