a body corporate, existing under and by virtue of the laws of Missouri, and having its chief office in the City of Kansas City, State of Missouri, hereinafter called Mortgagee,

Witnesseth: That whereas Mortgagor is justly indebted to Mortgagee for money borrowed in the principal sum of

EIGHTEEN THOUSAND AND NO/100 ----- DOLLARS,

to secure the payment of which Mortgagor has executed one promissory note, of even date herewith, payable to the order of Mortgagee at its office aforesaid or at such other place as the holder thereof may designate in writing, said principal sum being payable as set forth in said note with interest at the rate set forth therein, the balance of said principal sum with interest thereon maturing and being due and payable on the first AUGUST day of August, 19 85 to which note reference is hereby made.
