5. That he will keep the premises above conveyed in as good order and condition as they are now and will not commit or permit any waste thereof, reasonable wear and tear excepted.

6. Thist the Morigagor will keep the improvements now existing or hereafter erected on the mortgaged premises, insured as may be required from time to time by the Morigages against loss by fire and other insurad, casualises and coulingencies in such amounts and for auch periods as it may require and will pay promptly, when due, any premiums on such insurance provision for payment of which has not been made hereinhefore. All insurance shall be earried in companies approved by the Morigages and the policies and renewals thereof shall be held by it and have sitched thereio loss payable clauses in favor of and in form acceptable to the Morigage. In event of loss he will give immediate notice by mail to the Morigagee who may make proof of loss if not made promptly by the Morigagor, and each insurance company concerned is hereby antiborized and directed to make payment for such loss directly to the Morigagee instead of to the Morigagor and the Morigage jointly, and the insurance proceeds or any part thereof, may be applied by the Morigage a tits option, either to the reduction of the indebtedness hareby secured or to the restoration or repair of the property damaged. That if the Mortgagor fails to make any payment provided for in this mortgage for taxes, insurance premiums, repair of the premises, or the like, then the Mortgagee may pay the same and all sums so advanced, with interest thereon at the rate set forth in the note secured hereby from the date of such advance, shall be payable on demand and shall be secured hereby.

The Mortgagor further agrees that should this mortgage and the note secured hereby not be eligible for insurance under the National Housing Act within 8 months from the date hereof (written statement of any officer of the Federal Housing Administration or authorized agent of the Federal Housing Commissioner dated subsequent to the 8 months lime from the date of this mortgage, declining to insure said note and this mortgage, being deemed conclusive proof of such ineligibility), the Mortgage or the holder of the note may, at its option, declare all sums secured hereby immediately due and payable.

The Mortgagor covenants and agrees that so long as this mortgage and the said note secured hereby are insured under the provisions of the National Housing Act, he will not execute or file for record any instrument which imposes a restriction upon the sale or occupancy of the mortgaged property on the basis of race, color, or creed. Upon any violation of this undertaking, the Mortgagee may, at its option, declare the unpaid balance of the debt secured hereby immediately due and payable.

Notice of the exercise of any option granted herein to the Mortgagee is not required to be given. The covenants herein contained shall bind, and the benefits and advantages shall inure to, the respective heirs, executors, administrators, successors and assigns of the parties hereto. Whenever used, the singular number shall include the plural, the plural the singular, and the use of any gender shall be applicable to all genders.
