This Indenture, Made this 26th day of November, A. D. 1965, between

and American Finance Corporation, 712 Massachusetts Street

of Lawrence, Douglas County, in the State of Kansas, of the second part:

WITNESSETH: THAT SAID PARTIES OF THE FIRST PART, in consideration of the sum

of TWO THOUSAND SEVEN HUNDRED THIRTY EIGHT (\$2,738.00) DOLLARS,

the receipt of which is hereby acknowledged, do by these presents, Grant, Bargain, Sell and Convey

unto said party of the second part, its heirs and assigns, all of the following described real

estate situated in Douglas County and State of Kansas, to-wit:

BLOCK 9, LOT 20, LIEZPLACE an addition to the City of Lawrence, Kansas, property commonly known as 716 Arkansas Street, Lawrence, Douglas County, Kansas.

TO HAVE AND TO HOLD THE SAME, Together with all and singular, the tenements, hereditaments and appurtenances thereto belonging or in any wise appertaining, forever.

PROVIDED ALWAYS, And these presents are upon this express condition, that whereas, said The parties of the first part

have this day executed and delivered certain promissory note \$2,738.00 writing to said party of the second part, of which the following Loan # 9448, Dated 26 November 1965 for the amount of \$2,738.00 to be paid in monthly installments of \$71.00 each for a period of 7 months.

Now, If said parties of the first part shall pay, or cause to be paid, to said party of the second part, its heirs or assigns, said sum of money in the above described note mentioned, together with the interest thereon, according to the terms and tenor of the same, then these presents shall be wholly discharged and void; and otherwise shall remain in full force and effect. But if said sum or sums of money, or any part thereof, or any interest thereon, is not paid when the same is due, or if the taxes and assessments of every nature which are or may be assessed and levied against said premises or any part thereof, are not paid when the same are by law made due and payable, then the whole of said sum and sums, and interest thereon, shall and by these presents become due and payable, and said party of the second part shall be entitled to the possession of said premises.
