WHEREAS, the first part les, for and in consideration of the sum of Two Thousand Dollars (\$2,000.00) - - - - - to them in hand paid by the said second part y, the receipt whereof is hereby acknowledged, he ye granted, bargained, sold, and conveyed, and by these presents do grant, bargain, sell and convey unto the said second part y and to their heirs, successors and assigns forever, all of the following described tract(s), piece(s) and parcel(s) of land lying and situated in the County of Douglas and State of Kansas, to-wit:		
Lots Numbered Three (3) and Four (4), in Block number Thirteen (13), in Lane's Second Addition to the City of Lawrence, in Douglas County, Kansas. Otherwise known as 1011 Indiana Avenue, Lawrence, Kansas.

WHEREAS, the said first part les, he ye this day executed and delivered one certain promissory note in writing to the said second part y payable at 5211 South Greenwood Avenue, Chicago, Illinois, 60615, a true copy of which is hereto attached and made a part hereof as follows, to-wit: December, 1965.		
For Value Received, we promise to pay Alpha Kappa Alpha Sorority, Inc. or order, the sum of Two Thousand DOLLARS, \$2000.00 at 5211 South Greenwood Ave, Chicago, Ill. in monthly installments, payable as follows, to-wit: Thirty-eight and 67/100 Dollars on the 10 th day of January, 1966, and Thirty-eight and 67/100 Dollars on the 10 th day of each succeeding month thereafter, until the whole sum named is fully paid with interest from this date at the rate of six per cent per annum. Each installment shall be first applied in payment of the interest and then on the unpaid balance of the principal sum. If default is made in payment of any installment when due, then all the remaining installments shall become due and payable at once, and bear interest at eight per cent per annum. Privilege is given to pay two or more installments at any payment time.
