This mortgage is given to secure the payment of the principal sum of Thirteen Thousand Five Hundred and 00/100—Dollars (\$ 13,500.00 ), as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein-by reference, payable with interest at the rate of Five and One-Fourth per centum (1.52 %) per annum on the unpaid balance until paid, principal and interest to be paid at the office of The Fidelity Investment Company fn Michita, Kansas , or at such other place as the holder of the note may designate in writing, in monthly installments of Seventy-Four and 66/100 1966 , and on the first day of each month thereafter, until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of a February , 19 96.

## The Mortgagor covenants and agrees as follows :
