## HERRICKS STATIONS AND MISCELLANEOUS REAL ESTATE

The Regular Stations and Miscellaneous Real Estate of the Company, including but not limited by the enumeration thereof, the following:

All that certain piece and parcel of land situate in the County of *Barber, State of Kansas*, described as follows:

- (1) *HERRICKS STATION*: A tract of land ten feet (10') square of the Southwest corner of Lot Seven (7) in Block Thirty-seven (37) in the City of Kiowa, Barber County, Kansas.

All those certain pieces and parcels of land situate in the County of *Cherokee, State of Kansas*, described as follows:

- (1) *HERRICKS STATION*: A tract commencing at the Southwest corner of Lot Number Four (4) in Block Number Twelve (12) in the First Addition to the City of Columbia, Cherokee County, Kansas, according to the recorded plat of said addition, thence running North ten feet, thence East ten feet, thence South ten feet, thence West ten feet to the place of beginning.

- (2) *HERRICKS STATION*: A tract commencing at the Southwest corner of Lot Thirty-one (31), Battle Hill Addition, thence East ten feet (10'), thence North eight feet (8'), thence West ten feet (10'), and South eight feet (8') to the place of beginning, all in the City of Baxter Springs, Cherokee County, Kansas (Title reverts to owner of Lot Thirty-one (31) in the event tract shall no longer be used for a regular station).
- (3) *PURE YARD (TERRACE)*: The West 22 feet of Lot Seven (7), Eighth (8), Nine (9), Ten (10), Eleven (11), and Twelve (12) in Block Five (5), Griswold and Hanks Addition to the City of Baxter Springs, Cherokee County, Kansas.

All that certain piece and parcel of land situate in the County of *Cloud, State of Kansas*, described as follows:

- (1) *HERRICKS STATION*: A tract of land twelve feet East and West by twelve feet North and South situated in the North-

east corner of Lot Number Ten (10), Block Number Twelve (12), City of Kiowa, and described as follows: Beginning at the Northeast corner of Lot Number Ten (10) in Block Number Twelve (12) City of Kiowa, thence running South on the East line of said lot twelve feet (12'); thence West twelve feet (12'); thence North twelve feet (12'); thence East on the North line of said lot twelve feet (12') to the place of beginning.

All that certain piece and parcel of land situate in the County of *Harper, State of Kansas*, described as follows:

- (1) *OFFICE, KIMBERLY & WAINWRIGHT*: The West half of Lot Three (3) and the East half of Lot Four (4) in Block Thirty-six (36) in the Original Town of Harper, Harper County, Kansas.
