

- (2) **Boulevard Survey:** A tract beginning at the Northeast corner of Lot Fifteen (15) in Block Three (3) in the U. K. Meyer Addition to the City of Wellington, Sumner County, Kansas, running thence West ten feet (10'); thence South ten feet (10'); thence East ten feet (10'); thence North ten feet (10') to the place of beginning.
