426 5. Mortgagee may at any time and from time to time without notice and without affecting the personal lia-bility of any person for payment of any indebtedness hereby secured or the lien hereof on the remainder of said pre-mises, do any or all of the following: (a) release any person liable for any indebtedness hereby secured; (b) release any part of said premises from the lien hereof; (c) by agreement with any person obligated on any indebtedness hereby secured or having any interest in said premises extend or renew all or any part of said indebtedness. 6. In the event of the passage after the date of this instrument of any law deducting from the value of the land for the purpose of taxation any lien thereon, or providing or ohanging in any way the laws now in force for the taxation of mortgages of debts secured thereby, for state or local purposes of the manner of the collection of any such taxes so as to affect the interest of the Mortgage, the whole sum secured by this instrument with interest thereon, at the option of the Mortgage, shall immediately become due, payable and collectible without notice. 7.
