to secure the payment of Eighty-seven Thousand Five Hundred and No/100 - - - - - - -

dollars (\$ 87,500.00) evidenced by a note of even date in said amount payable to the mortgagee, with interest as therein stated, and payment thereof being due: in monthly payments as provided in said note.

The mortgagors further agree, for the protection of the rights of the mortgagee, or its assigns, as follows:
