this indenture do GRANT, BARGAIN, SELL and MORTGAGE to the said party of the second part, the

following described real estate situated and being in the County of Douglas and State of

- (1) Beginning at the Southeast corner of Section Twenty-four (24), Township Twelve (12) South, Range Nineteen (19) East; thence West along the South line of said Section to the right-of-way held, occupied, and used by the Atchison, Topeka & Santa Fe Railroad Company; thence in a Northwesterly direction along said right-of-way line to the North line of the South one-half (S $\frac{1}{2}$) of the Southeast One-quarter (SE $\frac{1}{4}$) of said Section Twenty-four (24); thence East along said North line to the East line of said Section Twenty-four (24); thence South along the East line of said Section Twenty-four (24) to the point of beginning, except right-of-way condemned by City of Lawrence, Kansas, in Case No. 18080 in the District Court of Douglas County, Kansas;
