This assignment of rent shall continue in force until the unpaid balan of said note is fully paid. It is also agreed that the taking of possession hereunder shall in no manner prevent or retained party in the collection of said sums by foreclosure or otherwise.

The failure of second party to assert any of its right hereunder at any time shall not be construed as a waiver of its right to assert the same at a later time, and to insist upon and enforce strict compliance with all the terms and provisions in said note and in this mortgage contained.

If said first parties shall cause to be paid to second party the entire amount due it hereunder and under the terms and provisions of said note hereby secured, including future advances, and any extensions or renewals hereof, in accordance with the terms and provisions thereof, and comply with all the provisions in said note and in this mortgage contained, then these presents shall be void; otherwise to remain in full force and effect, and scoon party shall be entitled to the immediate possession of all of said premises and may, at its option, declare the whole of said note due and payable and have forcelosure of this mortgage or take any other legal action to protect its rights, and from the date of such default all items of indebtendess hereunder shall draw interest at the rate of 10% per annum. Appraisement and all benefits of homestead and exemption laws are hereby waived.

This mortgage shall extend to and be binding upon the heirs, executors, administrators, successors and assigns of the respective parties hereto.
